AUCTION NOTICE

Sealed Tenders are invited to dispose off two Unserviceable and Condemned vehicles i.e. GA-01-G-1038 (Tata Sumo) & GA-01-G-1308 (Maruti Zen) on "As is where is basis" so as to reach the Office of the Directorate of Education, Porvorim upto 10.30 a.m. on 14/11/2018.

Tenders will be opened in the office of the Directorate of Education, Porvorim on same day at 11.00 a.m. during which period the tenders or their authorised representatives may remain present. Tender catalogue alongwith terms and conditions can be obtained from the same office on all working days/hrs. on payment of Rs.100/- (Rupees One hundred only) (non-refundable) per set from 25/10/2018 to 13/11/2018 (upto 4.00 p.m.).

Lots shall be available for inspection from 25/10/2018 to 13/11/2018 (upto 4.00 p.m. as per the locations mentioned in the tender catalogue.

- (a) E.M.D. will be at the rate of 25% of the quoted bid value per lot in case of disposal of vehicles. The same shall be in the form of D.D./Pay Oder/D.C.R. of any scheduled Bank drawn in favour of Directorate of Education, Porvorim-Goa payable at Panaji and to be enclosed by all bidders alongwith their offer.
- (b) The balance 75% of highest bid value of each lot should be paid by the bidder within 7 days from the date of issue of sale letter/acceptance letter by the Department to the successful bidder.


This balance payment shall also be in the form of Pay Order/D.D./D.C.R. of any Scheduled Bank drawn in favour of Directorate of Education, Porvorim-Goa, payable at Panaji. In case of failure to make balance payment in time the amount deposited will stand forfeited.

The successful bidder shall lift lot(s) within 3 weeks of receiving intimation letter/Delivery order from Department and failure to do the same, then the amount deposited as per Clause (b) and (c) above shall stand forfeited.

GST shall be payable on disposal of all condemned vehicles.

The Department reserves the right to accept or reject any or all tenders without assigning any reasons thereof.
